By submitting a proposal, Subcontractor acknowledges and agrees to all terms and conditions set forth in the Standard Subcontract Agreement included in the Bidding Documents. McGough must receive a fully executed Standard Subcontract Agreement and Certificate of Insurance prior to commencement of Work

Pre-Qualification Requirements:

McGough and Subcontractor agree that Subcontractor shall be required to provide prequalification information as defined by Contractor prior to Contract Award and at any time during the entire duration of the Contract. Prequalification information shall be provided in electronic format and shall be submitted to Contractor using the CMiC system prescribed by Contractor. If Subcontractor is notified of intent to award a subcontract, and Subcontractor has NOT completed their Prequalification, Subcontractor will have 10 days to complete prequalification or contract may be awarded to another subcontractor.
